

# PROCUREMENT NOTICE PROVISION OF REPAIR SERVICES FOR TANK NO. 68

## INVITATION TO BID

#### **Introduction**

- Paria Fuel Trading Company Limited (Paria) is a state-owned Company in the Fuel Logistics and Trading Business with access to strategic linkages and high-level market intelligence. Our significant infrastructure positions us to offer safe, responsible and efficient terminal operations which will facilitate the reliable importation, exportation and trading of petroleum products.
- 2. Paria hereby invites qualified firms to submit a tender for the repairs of Tank 68 according to API 653. This tank is one hundred and fifty feet (150') in diameter and fifty-six feet (56') in height, with an estimated total capacity of one hundred and fifty thousand barrels (150,000 BBLS). The scope of work includes extensive mechanical repairs and fabric maintenance as follows: Work Preparation and Close-Out, Tank Structural Repairs, Tank Internal Repairs, Tank External Repairs, System Piping and Valves, Tank Testing and Calibration, Coating and Liner Repairs, and Civil Repairs. The contractor shall provide technical expertise. supervision, manpower, equipment, consumables & offsite facilities required to perform tank repairs
- 3. The Invitation to Bid (ITB) will be issued to qualified and experienced providers of the works/services required, pre-qualified in the Procurement Depository maintained by the Office of Procurement Regulation (OPR) under the Line of Business (LOB) 72121507 Tank construction and servicing. Proponents MUST apply in the highest value category supported by their past experience in the above LOB.

#### **Limitation to Participation**

1. In accordance with section 28 of the Public Procurement and Disposal of Public Property Act 2015 as amended, participation in these proceedings is limited to providers of the works/services described in items 2 & 3 above.

#### **Minimum OPR Pregualification Requirements**

Company Certificate of Incorporation, Notice of Directors, BIR, NIS and VAT Certificates (clearance documents will be required during bid process), STOW or HSE Management System, Insurance Certificates - Workmen's Compensation and Public Liability, minimum of 2 years' experience, Company Profile, References and relevant work experience, Audited Financial Statements for past two (2) years.

#### **Invitation to Prequalify**

The deadline for submission of documents and application for pre-qualification in the Procurement Depository, in response to the Procurement Notice is Monday 30th September 2024 @ 3:00pm.

#### **Tendering Submission**

The invitation to tender package is expected to be issued on 3rd October, 2024 to the suitably qualified and experienced firms in the required LOB.
